**RE:** Refresher Training Seminar

As you know, our Drug Free Workplace Policy has been in place since March 1, 2003 and the regulations continue to require a refresher course. **In order to continue to be a participant in the policy, you are required to attend a refresher training seminar.**

Due to the ongoing COVID-19 restrictions the 2022 DFWP Training will be conducted virtually with Zoom. Listed below are 5 separate Zoom Meeting dates and times. These are the only refresher training sessions scheduled for 2022. Again, this training is required to be in compliance with the policy. Annual drug testing is no longer required, however annual training is still mandatory.

When you click on or enter the Zoom Link provided you will be requested to enter your name, **please provide your full name and at the end of your last name add the number 573, to identify your Local.** This will allow us to identify that you attended the training, and you are eligible for the \$25.00 stipend from your employer. Once the 5 trainings have been completed, your name will be provided to your employer, and they will issue your stipend. We will also work with your employer to get the new DFWP card to you. Cards will also be available at the Union Hall for pick up or to be mailed.
